REQUEST FOR RENTAL INCREASE/DECREASE FORM

Housing Choice Voucher Program owners must request a rent increase, in writing, at least 60 days prior to the effective date of the proposed increase. HCHA will agree to such an increase only if the amount is considered reasonable according to rent reasonable standards. No rent increase is permitted during the initial term of the lease, and owners may request a rental increase only once every 12 months. **Note: After receiving this request, HCHA will evaluate the reasonableness of any rental increase based on current market conditions. If this evaluation reveals that the current contract rent amount is unreasonable, the request for a rental increase will be denied and owners will be required to reduce their current rent amount.**
