ITEM 1: Written Questions Received by January 4, 2019.

- 1. End Table and Coffee Table – general spec calls for solid wood. Our tabletops are decorative high pressure laminate throughout. It's highly durable and available in many colors – to include solid wood patterns. Is this an acceptable alternate?*

At this time the HCHA is requesting that all bidders submit a bid based on what is within the specifications.

- 2. Full captains bed – general spec calls for solid pine construction. Our units use a combination of both decorative high pressure laminate with steel frame stock. The drawer assemblies are solid wood construction with dovetail joints. Is this acceptable?*

At this time the HCHA is requesting that all bidders submit a bid based on what is within the specifications.

- 3. Living Room – Bid Sheet requests solid wood and veneers – A high pressure laminate and metal is much more durable and will withstand condensation from glasses and spills where veneers will not and will leave water rings or damaged areas. Can high pressure laminate be used?*

At this time the HCHA is requesting that all bidders submit a bid based on what is within the specifications.

- 4. Full Captain Beds – Solid Pine Construction – Easy access for bed bugs and hard to maintain. Can metal and high pressure laminate be used which would be more durable and last longer while still providing storage underneath?*

5. Mattress – Do you prefer a bed bug resistant mattress? There is a specific mattress that we currently use for affordable and supportive housing programs that is also water resistant. If not, do you need a bed bug cover for a regular mattress?

6. TV Lounge – Can a laminate top table with metal legs be used instead of wood legs for longevity?
